Scope of Work/Experience Required: (i) To supervise the overall Security arrangements in CSIR-CRRI office premises along with Maharani Bagh Staff Quarter of CRRI including the DG Bungalow and residence of 03 CSIR Directors at Maharani Bagh. (ii) To allot duties to all the security staff and to conduct surprise checks of the security staff while on duty, both during daytime and night hours. (iii) To maintain liaison with public and CSIR-CRRI officials after and before office hours for which a telephone connection is available at rentfree accommodation. (iv) To supervise the security arrangements 24x7 including Saturday, Sunday and all other Gazetted Holidays as well as any other day on which the office is partially or fully closed. (v) To handle other related works, as and when assigned by the CSIR CRR\Authorities from time to time. (vi) The Security Consultant should have working knowledge of Computer. (vii) The Security Consultant will have to live 24x7 within the CRRI Campus (viii) The Security Consultant to be engaged shall be provided an accommodation. The occupation / stay of the Security Consultant in this accommodation 24x7 will be compulsory. However, use of utilities shall be chargeable. The accommodation provided to Security Consultant will be vacated by him/her on completion of the tenure and no extension in this regard will be entertained.

# **Terms & Conditions for the engagement:**

- (i) **Period of engagement:** Initially for six months or till the regular incumbent joins the posts, whichever is earlier. The engagement period may be extended at the discretion of the Competent Authority, CSIR-CRRI. subject to functional need. However, the maximum age, upto which a retired employee can be engaged, will be 65 years.
- (ii) **Job location:** CSIR-Central Road Research Institute (CRRI), Delhi Mathura Road, New Delhi -110025, Near Sukhdev Vihar DTC Bus Depot. Nearest Metro stations: Jasola Apollo (Violet Line), Sukhdev Vihar (Magenta Line). Nearest Bus Stop: CRRI.
- (iii) **Age Limit:** Candidate should not be more than 64 years of age on the last date of receipt of applications.

- (iv) Remuneration: Retired employees will be paid fixed remuneration (@Pay drawn at the time of retirement Basic Pension) as per Department of Expenditure OM dated 09.12.2020. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment /percentage increase during the contract period.
- (v) **Working Hours:** (a) The retired employees who will be selected as Consultant (Security) will have to live in CSIR-CRRI campus 24 x 7, no extra remuneration will be paid (b) Consultant shall mark his attendance in Attendance Register mandatorily or on any applicable mode, failing which, it may result in deduction of remuneration.
- (vi) Leaves: As per Department of Expenditure OM dated 09.12.2020 or any subsequent instructions issued on the subject.
- (vii) **Terms of engagement:** (a) Selected candidates will be engaged purely on contractual basis initially for a period of 06 months and will not confer any right for regular appointment in the department including any allowance such as DA, Transport facility, HRA, residential telephone facilities (b) The engagement of the contractual position can be terminated at anytime by giving one month's notice. (c) The engagement will be as per CSIR Circular No. No.5-1(354)/2016-PD dated 02.12.2022 and any subsequent guidelines issued from time to time.
- (viii) Selection Procedure: (a) A Walk-in-Interview will be conducted in CSIR-CRRI through a duly constituted Screening-cum-Selection Committee (c) The decision of the Competent Authority, CSIR-CRRI regarding selection of candidate will be final and no correspondence on this subject will be entertained.
- (ix) General Conditions: (a) The selected candidates will be governed by the Official Secret's Act, 1923, as amended from time to time and will not disclose to any unauthorised person(s) any information/data that may come to their notice during the period of their engagement in the department. All such documents will be the property of the CSIR-CRRI.
  - (b) They will not utilise or publish or part with, to a third party, any part of the data or statistics or proceedings on information collected for the purpose of their assignment or during the course of assignment for the department without the express return consent of the Department.
